Vendors accepted and invited to participate in the Reverse Auction will be notified prior to the auction date either by phone or email.

This solicitation includes 3 separate auctions. Bid shall be for items noted per auction. Vendors may bid on a single auction or multiple auctions. Prices should include delivery. Bids shall be for a two-year period. Contract may be terminated by either party at the end of the first year. Written notice of termination must be given 60 days prior to the end of the contract period, or the bid will continue for the second year.

The East Mississippi Community College Board of Trustees reserves the right to reject any or all bids and to negotiate with the lowest/best bidder. EMCC reserves the right to award the bid as a whole or by individual line item.

## LP GAS BID SPECIFICATIONS

All prices shall be FOB East Mississippi Community College, Scooba, MS.

**The bid period shall be: July 1, 2025 - June 30, 2027**

The winning bidder must provide & hook-up, according to State Regulations, approximately fifteen (15) 1000 gallon tanks, seven (7) 500 gallon tanks, one (1) 350 gallon tank, and any additional tanks needed during the year.

Any expenses incurred by EMCC which are attributed to improper installation of tanks & gas lines by the winning bidder will be reimbursed to the institution by said bidder.

All delivery tickets shall have the proper location of the tank being filled legibly entered on said tickets (a list of names will be provided to the winning bidder), and must be signed by the Maintenance Supervisor or his representative. Any delivery ticket received without such data will not be paid by EMCC.

The winning vendor shall insure that all LP Gas present in the vendor-supplied tanks at the time of the bid is placed in the tanks provided by said Vendor at no cost to EMCC.

All tanks shall be neat in appearance and EMCC may, at its discretion, require that some tanks be painted during the year, at the expense of the winning bidder.

EMCC may, at its discretion, notify the winning bidder to discontinue delivery to any location at any time.
